

## I. General obligation

The Game Rentacar leases, and the Renter leases, under the conditions specified in the lease agreement, the motor vehicle specified in the lease agreement. The Renter may sublease the vehicle or let it be used by a third party only with the prior written permission of the Game Rentacar. Any declaration concerning this contract - with the exceptions specified in the contract - can only be validly made in writing. If the Renter provides any untrue information to the rental agreement, violates any essential obligation specified in the rental agreement or the general terms and conditions, the Game Rentacar is entitled to terminate this rental agreement with immediate effect. The Game Rentacar expressly reserves the right not to establish a rental relationship with the registering client after the registration on the Internet for reasons arising within its own interests.

## II. Use of the vehicle

The Renter may only fill the rented vehicle with the required fuel. The cost of fuel is borne by the Renter during the entire duration of the rental agreement. The Renter is prohibited from driving the vehicle under the influence of alcohol or drugs; enter the vehicle in sports events and/or use it for test purposes; to tow another vehicle with the vehicle (the exception to the towing ban is a vehicle with a tow hook); to commit a violation or a crime with the vehicle, or to cross the national border illegally; engage in any other behavior that is contrary to the purpose of this contract. The Renter may leave the territory of Hungary with the vehicle only with the prior written permission of Game Rentacar. In case of crossing the border without Game Rentacar's permission, the Renter is obliged to pay a fine of **500 EURO**. Game Rentacar may deduct the penalty from the security deposit paid by the Renter. The Game Rentacar hands over the vehicle to the Renter, fully filled with lubricant and fuel, together with its accessories. The Renter is obliged to return the vehicle and its accessories to Game Rentacar in the same condition as when they were handed over. The Renter can only use the vehicle for its intended purpose. The Renter is obliged to check the oil and fluid level in the vehicle every 1000 km and top up if necessary. The Renter is obliged to compensate for damages exceeding the amount of wear and tear associated with intended use.

## III. Rental fee, rental period, payment terms

The rental fee is based on the Game Rentacar's price list valid at all times. Fees that differ from this (e.g. for the joint rental of several vehicles) are fixed by the Parties in a separate agreement as an addendum to the rental contract. The car rental fee does not include the right to use roads subject to a fee in any country. If the Renter wishes to use toll road sections in Hungary, he can purchase the road use permit entitling him to do so at the Game Rentacar's office at the current list price when picking up the rental car. The payment of the security deposit is only possible by blocking or charging it on a credit card in the name of the Renter. Visa and Mastercard cards are acceptable for deposit blocking purposes. In the event that the Renter does not fulfill any of its payment obligations within the deadline, the Game Rentacar may use the entire amount of the security deposit to satisfy its claim. In the event of late payment by the Renter, he is obliged to pay late payment interest. The default interest rate is twice the current central bank base rate.

The Renter agrees to the fact that if he is more than 30 days late in paying any of the Game Rentacar's invoices, the Game Rentacar - in addition to the late payment interest - will charge him a recovery cost of 50 EURO + VAT, after the first demand for payment. The Renter consents to the fact that in the event of a repeated demand for payment or payment through a legal representative, the Landlord will charge him an additional collection cost of 75 EURO + VAT. The Renter agrees that if the payment of any of the Game Rentacar's invoices is delayed by more than 10 days, the Game Rentacar will suspend the service specified in this contract until the invoice is paid. The Renter is also obliged to pay rent for the duration of the break. If the Renter does not return the vehicle within the deadline, he must pay a full daily rental fee. The grace period is 1 hour. There is no refundable rental fee for a car that is returned within the rental period! The extension of the rental period must be approved in writing by Game Rentacar 24 hours before the end of the rental period. In case of further use without permission, the Renter is obliged to pay an additional usage fee of EUR 50 + VAT per day, in addition to the rental fee. The Renter is obliged to pay all costs resulting from the delay (transportation of the car, search, etc.) to Game Rentacar. All costs incurred during the rental period (fuel, parking, highway tolls other than those specified in the rental contract, etc.) are borne by the Renter. If the Renter returns the vehicle to the Game Rentacar with an empty fuel tank, the Renter must reimburse the Game Rentacar for the price of the missing fuel, as well as a refueling fee of 20 EURO + VAT. The Contracting Parties note that their written statements are considered communicated when they are handed over to the addressee or another person entitled to receive them, or when the electronic document becomes accessible to them. The communication is effective even if the recipient or another person entitled to receive it refuses or intentionally prevents it. The Contracting Parties state that e-mails sent to the Renter's e-mail address specified in the lease agreement must be considered communicated the day after they are sent.

## IV. Insurance and Indemnity Liability

The Game Rentacar declares that he has valid compulsory and casco insurance for the vehicle specified in the rental agreement. In the event of a domestic traffic accident, in which the Renter is not the at-fault party, a properly filled out accident report in European format, signed by both parties, is required from the at-fault party. If the tortfeasor does not admit his responsibility, the circumstances of the accident must be verified with a police report. In the event of a traffic accident abroad, a certificate from the foreign insurer of the injured party and a police report are required. In the absence of the above, the full damage must be reimbursed by the Renter. The casco insurance taken out by the Game Rentacar for the vehicle that is the subject of this contract includes a 10% deductible. The 10% deductible means that in the event of an accident caused by the Renter's fault, the Renter is obliged to **pay 10% of the damage, but a minimum of EUR 1200**, to the Game Rentacar. The Renter has the option to take out insurance with reduced deductible for a separate fee. In the event that the vehicle is stolen, or in the event that the vehicle is a total loss in a traffic accident caused by the Renter, **the Renter must pay 10% of the value of the vehicle at the time of theft or accident** to the Game Rentacar. The Renter is obliged to compensate the full damage in the event of any damage related to the Renter's behavior (in particular, but not exclusively in the following cases: damage caused under the influence of alcohol or other mind-altering substances, loss of a driving license and/or vehicle ignition key or leaving it in the vehicle, not damage caused while using a vehicle with a valid driver's license, damage resulting from a deliberate and gross violation of KRESZ regulations), when the insurance company does not or only partially reimburses the Game Rentacar's damage. In the event of a traffic accident caused by the Renter's fault, the Renter recognizes the remaining duration of the lease as lost time and pays rent for the justified time of repair (according to the audatex prg). In the event of a lack of accessories, the Renter must reimburse the current purchase price of the accessory. In case of loss or theft of the original factory key, the Renter is obliged to pay for the replacement of the locks. In case of loss or misappropriation of the registration number or license, the Renter is obliged to pay the cost of obtaining the registration documents or registration number to the Game Rentacar. In the case of locking the vehicle's ignition key in the vehicle, the Renter is obliged to pay a service fee of 1 EURO + VAT / km (double the distance between the Rental site and the locked car), but a minimum of 100 EURO + VAT, to the Game Rentacar for unlocking the vehicle with a spare key. In the event of a traffic accident caused by the Renter's fault, the Game Rentacar shall bear the cost of transporting the vehicle back to the site up to 300 EURO, the Renter shall bear the cost exceeding this amount.

## V Repair and maintenance

If the vehicle breaks down for reasons not attributable to the Renter, the Renter must notify the Game Rentacar as soon as possible. After receiving the notification, the Game Rentacar is obliged to provide a replacement vehicle of the same category in accordance with the contract within 24 hours. The telephone number indicated on the rental contract is used to report accidents and technical faults. The Renter is obliged to report the odometer reading of the vehicle subject to the lease contract once a month, no later than the 5th day of the month, to the Game Rentacar's email address [info@gamerentacar.com](mailto:info@gamerentacar.com). The Renter is fully responsible for damages resulting from the failure or delay of notification. The Renter is obliged to show up at the service designated by the Game Rentacar with the vehicle that is the subject of the rental agreement at the time indicated by the Game Rentacar. The Landlord will inform the Renter in writing of the date and place of the service at least 5 working days in advance. If the Renter does not show up at the service with the vehicle at the specified time, the Game Rentacar is entitled to immediately suspend its own service and to charge the Renter a default penalty of 200 EURO. In addition to the default penalty, the Renter is obliged to compensate the Game Rentacar for all damages caused by the failed service.

## VI. Game Rentacar's obligations

The Game Rentacar guarantees that the vehicle will be in working condition for the entire duration of the contract and that it will comply with the official regulations for keeping vehicles on the road.

## VII. Renter's obligations

The Renter declares that he has a valid driver's license and that he has obtained the driving practice necessary for safe driving. The rented vehicle can only be driven by the Renter and the drivers authorized by him, they cannot let anyone else drive it. The above provisions also apply in the event that the Renter is not a private individual (hereinafter: company), with the exception that the vehicle may only be driven by employees of the company if they meet the above-mentioned conditions. The Renter is obliged to use the vehicle and its accessories in the manner of a good owner. The Renter is obliged to ensure the safekeeping of the vehicle's documents.

## VIII. Final provisions

In matters not regulated in this contract, the provisions of the Civil Code shall govern. For the settlement of legal disputes related to the rental agreement, the Parties shall refer to the Budapest II. and III. A District Court is appointed. By signing the rental agreement, the Renter acknowledges the rental and other fees included in it, and also declares that he has read the rental agreement and the general terms and conditions, has taken note of its contents, and bears the consequences of not complying with them.

As a Renter, by signing this contract, I declare that I have taken over the vehicle indicated in the rental contract from the representative of GAME Rentacar Kft. for use. I acknowledge that subsequent costs may arise in connection with this rental contract (in particular, but not limited to: compensation due to damage to the rental car, refueling costs due to missing fuel, fines due to traffic violations, parking surcharges) and at the same time, I allow GAME Rentacar Kft. charge it to my bank card provided by me - for the purpose of locking a security deposit - within the framework of this lease. I acknowledge that in the case of returning the vehicle outside business hours, the Renter's liability for damages remains in effect until 8:00 a.m. on the next working day. At the same time, I undertake that if this is not possible (different type of payment, bank card that has expired in the meantime, lack of a limit permit), I will reimburse these costs in full against the invoice of GAME Rentacar Kft. Furthermore, I consent to the fact that GAME Rentacar Kft. may release my name and personal data for the purpose of data provision in official (violation, criminal) and parking, insurance and claims settlement matters without my consultation. I acknowledge and at the same time allow GAME Rentacar Kft. to charge the fees related to the vehicle rental (in particular, but not exclusively: rental fee) to my bank card specified above. At the same time, as a Renter, by signing this contract, authorize the representative of GAME Rentacar Kft. to block or charge the deposit to his bank card for the entire duration of the car rental. The Renter understand that the locked or charged security deposit remains locked for the entire duration of the rental. The Renter understand that the time of the actual release or return of the security deposit depends on the communication between the bank of the Renter and the bank of GAME Rentacar Kft, but maximum 30 days. If the security deposit is returned, the Renter is obliged to provide his bank account number in writing immediately upon the Lessor's request. The Renter recognizing the given bank account number as his own. The time for the release/refund is a maximum of 30 working days, in the case of a bank transfer, when the Renter's own bank account number is provided. GAME Rentacar Kft. has no other influence on the banking process of deposit release.
